



### 2022 Goat Grazing

The annual Goat Grazing began in March and will continue through approximately July 4, 2022. Here are a few helpful tips to keep in mind while the animals are grazing this season.

- Please keep pets and children away from electrified fencing, herds, shepherds, or shepherds' dogs.
- Please do not place any yard clippings, pesticides, or potted plants in the open areas where herds will be grazing.
- Please be sure to protect any plantings within two feet of fence lines by trimming, moving, or covering.
- Grazing containment fences will be placed near fencing that is adjacent to open spaces. For concerns regarding fencing placement near your property please contact CAPRA directly.

### Red Zone/Fire Hydrant Parking

- Parking in a Red Zone/ Fire Hydrant Parking in a red zone or within 15 feet of a fire hydrant will result in immediate towing of the vehicle.
- Red Zone Parking: Vehicle Code 21458 prohibits vehicles parking in a red zone. A red curb shall indicate no stopping, standing or parking whether the vehicle is attended or unattended.
- Fire Hydrant Parking: Vehicle Code 22514 prohibits stopping, parking, or leave standing any vehicle within 15 feet of a fire hydrant. ■

# Whitney Oaks Wildlife Notes

**Mourning Doves** are numerous in California and are commonly seen in Whitney Oaks. As you can see in my photos below, they have plump bodies, small bills, short red legs, and long pointed tail feathers. Their wings produce a whistling sound when they are taking off or landing.

Seeds make up most of their diet, so they spend a good share of the day on the ground whether in backyards or agricultural fields. They are easily attracted to bird feeders.

For the most part, males and females look alike. Courtship includes gentle preening each other around the neck and head-bobbing by the male. I love to hear their soft "cooing" calls during the spring nesting season. Some people say the cooing resembles a sad or mourning sound. I would rather think it sounds more like the dove calling to its mate.

While some bird species shy away from nesting near humans, mourning doves often build nests on the eaves or ledges of homes or backyard arbors. Their nests are typically made of twigs woven together and maybe some grass and little else. A few years ago, we had a pair of doves attempt to build a nest on a small 3-inch ledge over our front doorway. Every day for a while we would find sticks on the floor of our porch. They finally gave up and presumably built a nest elsewhere.

Females almost always lay 2 eggs. The eggs are incubated continuously with the male usually taking the day shift and the female the night shift. Young, called squabs, are hatched after approximately 14 days with eyes closed and although covered with down are first dependent on the adults to keep them warm. Squabs are fed a fat and protein-rich milky substance from the lining of the mother's crop ("crop milk") for a few days and then fed partially digested food (e.g., softened seeds). Amazingly, the young are ready to leave the nest in two weeks. However, after leaving the nest, the adults continue to feed them for an additional couple of weeks.
