Denied. Plan view drawing does not identify patio cover's dimensional setback from side property line; it appears the proposed cover is 2' from property line. Design Guidelines specify minimum 10' set back (page 13, paragraph 2 of Landscape Features). Architecture Committee suggests applicant redraw the plans so that the cover aligns with the house's identified 6' set back and resubmit modified drawing to Board for approval/denial.

Proposed pavers on both sides of existing concrete driveway to be maximum 2' wide, per side, to align with vertical stone veneer at sides of garage door. Pavers to terminate at end of driveway where driveway meets sidewalk.
