RULE CHANGE NOTICE

HILLCREST PARKING

A meeting regarding Hillcrest parking was announced 30-days prior and was held on March 23rd 2016 at 6:00 P.M. All owners and residents of the Hillcrest neighborhood were surveyed regarding whether they were affected by student parking and whether they were in favor of or opposed to the proposed parking restrictions. Most were in favor. The Board considered all written and verbal comments and **the following rule was adopted at the Special Board Meeting:**

“Parking on the private streets in the Hillcrest neighborhood to access Rocklin High School is prohibited, including for residents of the Whitney Oaks community. In order to enforce this restriction street parking in the Hillcrest neighborhood (on Hillcrest Drive from Crest to Western Way, Vivien Way, Pheasant Lane, and Chasen Court) shall be limited to a maximum of three (3) hours per day on school days and during school events. Vehicles parked on the private streets in the Hillcrest neighborhood on these streets in excess of three (3) hours on school days or during the school events will be towed without notice.”

This means students and others may no longer park in the

If you reside on the affected streets you will be mailed permits for daytime street parking in front of (or in the general area of) your home.

NEW SECURITY PATROL SERVICE

We are pleased to announce that the Whitney Oaks Board of Directors has interviewed candidates and hired a new company to provide armed security patrol and parking enforcement services for the Association. The new company will provide 5.5 hours of patrols per night (random visits) and will be on call from 8:00 PM to 6:00 AM. Attached please find a welcome letter and a page of Q&A from Paladin Private Security. For vacation checks please call the 24-hour dispatch number at 916-331-3175. The dispatcher will ask for your name, address, phone number where you or your trusted person can be reached in an emergency (if you are going out of the country), and the date range that you will be gone. Please tell the dispatcher if you will have a house

sitter or someone coming by to feed pets, collect the mail, etc. You can also contact dispatch at any time to report suspicious circumstances, crimes in progress, parking issues, etc, and if you call during the service hours of 8:00 PM to 6:00 AM an officer will be dispatched to investigate.

NOTICE OF PROPOSED CHANGES IN PAINT COLOR PALETTE

After reviewing the current paint palette for areas outside of Springfield and Units 39/44, and discussing it with the Architectural Committee, the Board has decided to move forward with updating the approved palette per the ARC's recommendation. Colors from the Kelly-Moore "Historic Lifestyles of The West" brochure that were on the list would be removed. Colors added to the "Exterior Classic Colors and Custom Combinations" brochure since the 2013 list was adopted would be added to the Association's approved color palette. Attached is a proposed revised color list. PARKING ENFORCEMENT CHANGE

As announced, the Board discussed whether to change the policy and expand the window for tagging and towing particular vehicles from 1 month to 6 months or 1 year. This would help the Association more aggressively enforce the Association's parking restrictions. After comments were received and reviewed, the Board unanimously voted to expand the window for tagging and towing particular vehicles from 1 month to 3 months. This means that if a tow tag is placed on a vehicle, the vehicle may be towed without further notice within a 3-month time period. This rule is effective April 4th.

TELL TENANTS

Please be sure to tell potential tenants about the parking and other rules. If you rent out your property in Whitney Oaks, you should give a copy of the Owner's Manual (available on WhitneyOaks.Net) to



all potential tenants during the screening process. Some tenants have moved into the community, not knowing about the prohibition on overnight street parking and this has put them in a difficult situation. Thank you.

Please be a responsible pet owner and pick up after your pet. Also please do not let your pet(s) out of your home/yard without a leash. Thank you for your cooperation.
