### **COMMUNITY HAPPENINGS**

- Replacement of the Trellis at the Hillcrest Pool: At their meeting on August 7<sup>th</sup> the Board of Directors voted to replace the wood trellis at the Hillcrest Pool (which has dry-rot) with a Weatherwood (coated aluminum) trellis. The new trellis will be installed in the fall and it's sure to look great!
- Street Sweeping: At their September meeting the Board will be reviewing proposals for street sweeping throughout the community (except those streets recently sealed/paved). Once a proposal has been approved, we will schedule the street sweeping for October and advise homeowners of the street sweeping date in the October newsletter.
- Upcoming Projects include trail maintenance, completing the new BBQ areas on Hillcrest Drive, and repainting the red curbs throughout unit 44 (Sterling Drive area).
- The pools will be closed for the season on September 3<sup>rd</sup> (the day after Labor Day). While homeowners will still have access to use the pools, they will no longer be heated and pool monitors will no longer be manning the pools.
- After many months of research, reviewing homeowner feedback, and discussion at Board meetings, the Board of Directors voted that 2 Speed Humps will be installed on Pheasant Lane. We expect them to be installed in September.
