The 2023 Goat Grazing Season is underway and will continue through the end of July. Please be mindful of the advisements below during this grazing season.

Advisements:

- Please do not place any yard clippings, pesticides, or potted plants in the open areas where herds will be grazing.
- Please keep pets and children away from electrified fencing, herds, shepherds, or shepherd dogs.
- Please be sure to protect any plantings within two feet of fence lines by trimming, moving, or covering.
- Grazing containment fences will be placed near fencing that is adjacent to open spaces. For concerns regarding fencing placement near your property please contact CAPRA directly.

Vehicles such as these may be parked temporarily in a driveway or in a street in front of the owner’s lot for a period of not more than forty-eight (48) hours for the purposes of loading and unloading. 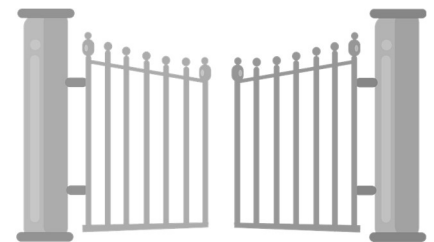

### **Important Announcement #1 Regarding Upcoming Election of Directors**

You are invited and encouraged to become a candidate for election to the Whitney Oaks Community Association's Board of Directors. There are three (3) seats up for election this year, currently held by Rick Jordan, Rick Campbell and a vacant seat. The three (3) candidates who receive the highest number of votes in the election will serve two-year terms.

Your Notice of Desire to be a Candidate and your optional Director Election Statement (described below) must be received by the Association prior to 5:00 p.m. on Tuesday, September 5, 2023 (the "Nomination Deadline"). Each Member who meets the qualifications set forth below and whose Notice of Desire to be a Candidate is received by the Association prior to the Nomination Deadline shall automatically be a candidate. There shall be no nominations from the floor at the Annual Meeting and votes for write-in candidates shall not be valid. It is each Member's responsibility to confirm that such Member's Notice of Desire to be a Candidate was received by the Association prior to the Nomination Deadline.

#### Candidate / Director Qualifications:

1. Except as provided in Section 1.D of the Election Rules, in order to be eligible to become a candidate, a person must, as of the Nomination Deadline, be a Member who is current in the payment of regular and special Assessments.
2. Except as provided in Section 1.D of the Election Rules, in order to be eligible for election to the Board, a candidate must, as of the date scheduled for close of the balloting period, be a Member who is current in the payment of regular and special Assessments.
3. Only one co-Owner of a particular Lot/Unit may serve on the Board at any time.

#### Director Election Statements:

Each candidate and each Member advocating a point of view may, but is not required to, submit (to the addresses listed above) a Director Election Statement that is reasonably related to the election. Director Election Statements shall not, when printed, exceed one side of a single 8½" x 11" page. Black and white copies of all Director Election Statements that are received by the Association prior to the Nomination Deadline will be included with the Ballot Packets that will be mailed to all Members and may be posted on the Association's official internet website, in accordance with the Association's Election Rules.

By submitting a Director Election Statement, you accept full responsibility for its content and agree to indemnify the Association and its agents and representatives for any and all damage arising from or related to any such content. It is each Member's responsibility to confirm that such Member's Director Election Statement was received by the Association.

# Whitney Oaks Wildlife Notes

A pair of **Red-shouldered Hawks** has frequented the area around the big loop of Clubhouse Drive for the last several years. I didn't know they nested there until this year when a large oak tree blew down in a storm. Their previously used nest was now easy to spot in a dead tree behind where the big oak once stood. In late March I noticed new nesting material had been added to the old nest. Soon afterwards I spotted the female crouched down in the nest presumably incubating eggs. I had read that red-shouldered hawk eggs are hatched in about 33 days so I continued my watch and about a month later the female was still on the nest but not crouched down, suggesting the eggs had hatched. A week or so later I decided to spend some time watching the nest from my car with camera in hand. About every 30 minutes that day the male flew in with food for the female and young (see photos below). In one of the photos you can see the male standing on the nest holding a dead lizard in its beak. The male would give the prey to the female who would tear the prey apart and feed it in small pieces to the young hawk chicks. (The proper name for young hawk nestlings is "eyas".) This continued for a couple more weeks until, one day, the three hawk chicks were alone on the nest. At this point the chicks were growing fast and both parents were bringing them food. On May 30th, the nest was vacated and the chicks were nowhere to be seen but I could tell the parents were nearby from hearing their calls. I have read that the parents will continue to feed the chicks for 8-10 weeks after leaving the nest but it is not uncommon for chicks to perish at this critical stage of their lives.

Red-shouldered hawks are typically found in wet woodland environments in California and the eastern half of the US. They are a medium to large hawk, not quite as large as our red-tailed hawks which also nest in Whitney Oaks. Pairs are monogamous and territorial. Prior to nesting this spring, I observed a third hawk giving the Clubhouse pair a hard time. Round and round they flew repeatedly screaming their *kee-rah* call.

The prey of red-shouldered hawks largely consists of rodents such as mice, voles and gophers. Other prey includes small birds, reptiles such as lizards, small snakes and amphibians.
